ORIENTATION ON GENDER ANALYSIS

A. RATIONALE

Gender analysis is a key process or step to understanding how gender relations can affect the implementation of a development program. Gender Analysis is also the starting point for gender mainstreaming. This process which involves the collection and analysis of gender and sex-disaggregated data using an analytical framework is often misunderstood, unappreciated, and regarded as burdensome.

The Harmonized GAD Guidelines as a gender analysis tool for programs is regularly applied to the Leasing and Financing Program. However, the use of this tool to improve the programming and be able to report the results of its contribution to women's economic empowerment has yet to be understood and appreciated.

Hence, this proposed training aims at developing that gender lens to be able to integrate gender in the different activities of LLFC's programs.
