GENDER MAINSTREAMING EVALUATION FRAMEWORK (GMEF) ORIENTATION AND ASSESSMENT WORKSHOP

A. RATIONALE

In compliance with Republic Act No. 9710, or the Magna Carta of Women (MCW) of 2009, government agencies are mandated to develop Programs, Projects, and Activities (PPAs) addressing gender issues and the needs of both women and men. These must align with the agency's GAD Agenda and make up at least 5% of the total agency budget.

To ensure these initiatives are responsive to actual needs, the PCW-NEDA-DBM Joint Circular No. 2022-03 requires agencies to conduct gender analyses or audits, with the Gender Mainstreaming Evaluation Framework (GMEF) as a key tool. The GMEF assesses the agency's gender mainstreaming level, identifies issues, and guides strategic interventions, ideally conducted annually or biennially.

LLFC's last GMEF assessment in 2022 formed the basis of its current GAD Agenda. With several gender initiatives implemented since then, a new assessment is necessary to evaluate progress and enhance ongoing efforts. Hence, this GMEF Orientation and Assessment Workshop is crucial and mandatory for all GFPS members, providing the knowledge and tools needed to sustain and strengthen LLFC's gender mainstreaming initiatives.
