### SEMINAR WORKSHOP ON STRENGTHENING GENDER ADVOCACY

### A. RATIONALE

On March 8, 2022, the Philippine Commission on Women issued Memorandum Circular 2022-02 on the Use of the Gender Focal Point System (GFFS) Functionality Assessment Tool. This is in support of the Magna Carta of Women Section 36b mandating the Creation and Strengthening of the GAD Focal Point System.

The self-assessment tool can help agencies in establishing baseline information on the level of functionality and identifying the mechanism's strengths and areas for improvement including underlying causes of the gaps in the performance of its mandates.

To ensure functional GFPs, agencies are enjoined to use the tool and periodically assess the functionality of their mechanism and submit to PCW the results of the assessment. This seminar aims to strengthen LLFC's GAD Focal Point System by assessing its functionality using the Philippine Commission on Women's prescribed assessment tool.
