# INVITATION TO QUOTE FOR Procurement for LLFC's Year End Fellowship (LLFC-CAP-25-029)

### **REQUEST FOR QUOTATION** (Small Value Procurement)

LBP Leasing and Finance Corporation (LLFC) through its Bids and Awards Committee (BAC) will undertake a Small Value Procurement in accordance with Section 53.0 of the 2016 Revised Implementing Rules and Regulations of the Republic Act No. 9184.

#### **BACKGROUND**

LBP Leasing and Finance Corporation (LLFC), a government-owned and controlled corporation (GOCC) and a subsidiary of Land Bank of the Philippines, is seeking a qualified supplier/venue for LLFC's Year End Fellowship. The services shall include meals, venue, and equipment to support LLFC's Year End Fellowship activities.

### **SCOPE OF WORK**

The supplier shall be engaged upon issuance of the Notice to Proceed, but not later than December 10, 2025.

The supplier must be capable of providing complete year-end fellowship program services, including the venue, catering, logistical arrangements, and other event amenities, in accordance with the following specifications:

- 1. **Event Date:** December 19, 2025 (Friday)
- 2. Event Time: 3:00 PM to 10:00 PM
- 3. **Duration:** One day event
- 4. Guaranteed Number of Participants: 100 pax
- 5. **Venue Location:** Preferably around Makati City
- 6. Accommodation Requirements:
  - o Use of a function room suitable for 100 guests, inclusive of tables, chairs, and standard decorations
  - o PM snack and buffet dinner with at least three (3) main course options, beverages, and dessert
  - o Complete sound system setup, including microphones, speakers, and background music provisions
  - o Projector and screen for presentations, videos, and corporate announcements
  - o Program logistics support, including stage setup, lights, and a designated area for raffle and games
  - o Photobooth and registration area within or near the function room
  - Free flowing coffee and tea
  - Wireless Internet Access
- 7. **Amenities:** Complimentary parking for attendees and access to available hotel facilities as applicable
- 8. **Additional Participants:** Any additional attendees shall be charged at the same or a lower rate as the regular participants and shall be billed separately
- 9. **Rates and Inclusions:** All price quotations must be stated in Philippine Pesos and inclusive of VAT and all other applicable taxes and charges

### **CONTRACT PAYMENT SCHEME**

Fifty percent (50%) of the contract price shall be made as down payment, with the remaining balance to be settled after the event.

- All quotations must include all applicable taxes and shall be valid for a period of thirty (30) calendar days from the deadline of submission of quotations. Quotations received in excess of the approved budget shall be automatically rejected.
- 3. Liquidated damages equivalent to one tenth (1/10) of the one percent (1%) of the value of Purchase Order not completed within the prescribed completion period shall be imposed per day to day of delay. LLFC may rescind the agreement once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of purchase order, without prejudice to other courses of action and remedies open to it.
- 4. The project shall be awarded to the proponent determined to have submitted the complete and lowest quotation including compliance with the Schedule of Requirements and Eligibility documents.
- 5. The prospective bidder shall be a Filipino citizen/sole proprietorship/partnership/Corporation duly organized under the laws of the Philippines.
- 6. LLFC reserves the right to reject any or all quotations at any time prior to awarding the project without thereby incurring any liability to the affected proponents and to waive any minor defects therein to accept the quotation as may be considered more advantageous to the Government.
- 7. Payment shall be within thirty (30) calendar days from date of acceptance. The procurement of LLFC is subject to a final VAT withholding of five percent (5%) in addition to the applicable withholding tax.
