LBP Leasing and Finance Corporation (LLFC) through its Bids and Awards Committee (BAC) will undertake a Small Value Procurement in accordance with Section 34 of the Implementing Rules and Regulations of the Republic Act No. 12009.

<u>BACKGROUND</u>	
In July 2025, LLFC procured a Firewall together with its bundled security subscriptions and technical support services, which serve as the Corporation's primary network security solution for protecting its information systems and network infrastructure against cyber threats. The existing security services, including Advanced Malware Protection, Email Filtering, Intrusion Prevention System (IPS), Web Filtering, Cloud Sandbox, Security Updates, and Analyzer Cloud, are scheduled to expire on July 7, 2026, and are essential for maintaining up-to-date threat intelligence and cybersecurity protection. In addition, the procurement of Multi-Factor Authentication (MFA) token licenses is necessary to strengthen the security of LLFC's VPN remote access by providing an additional layer of identity verification for authorized users.	
<u>OBJECTIVES</u>	
The objective for this procurement is to acquire Firewall Security Services and Multi-Factor Authentication Licenses for the Corporation.

Liquidated damages equivalent to one tenth (1/10) of the one percent (1%) of the value of Purchase Order not completed within the prescribed completion period shall be imposed per day to day of delay. LLFC may rescind the agreement once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of purchase order, without prejudice to other courses of action and remedies open to it.
4. The project shall be awarded to the proponent determined to have submitted the complete and lowest quotation including compliance to the Schedule of Requirements and Eligibility documents.
5. The prospective bidder shall be a Filipino citizen/sole proprietorship/partnership/Corporation duly organized under the laws of the Philippines.
6. LLFC reserves the right to reject any or all quotations at any time prior to award of the project without thereby incurring any liability to the affected proponents and to waive any minor defects therein to accept the quotation as may be considered more advantageous to the Government.
7. Terms of payment shall be within thirty (30) calendar days from date of acceptance. The procurement of LLFC is subject to a final VAT withholding of five percent (5%) in addition to the applicable withholding tax.
